Management included procurement of specialized subcontractors, direct coordination with FEAD team/customer/facility maintence, satisfying all preconstruction submittals and all inspections. This project required the removal for evaluation and repair of well pumping equipment for two wells with one reaching a depth of 980ft. During execution of this contract, NAWS China Lake was impacted with 2 large surface earthquakes. Therefore, DCM was required to perform additional cleaning, bailing, and surveying to ensure wells/ superlouvers were not fractured/damaged. Due to condition/wear of existing well components, DCM provided and installed new casings/inner shafts, pump, and motor along with applicable testing and commission of newly installed equipment. For this project, safety around hoisting operations via Semco 2180 well rig was of paramount concern. DCM worked closely with FEAD and NAVFAC crane team through entirety of project.

David Construction & Management, Inc. was tasked with the successful cleaning and inspection of the interior/exterior of 5 water tanks at USCG Training Center in Petaluma, CA. As per project requirements, DCM removed sediment or debris build-up from floor, ladder and piping, without creating turbidity. Upon completion of inspections, DVD's of interior conditions along with hard copy report/assessment summarizing work and findings were turned over to the USCG for review. All interior inspections were conducted by certified divers while tanks remained in service. For all existing cathodic protection systems, a NACE-certified technician performed all inspections of cathodic systems and anodes. As the competent/qualified entity, DCM also implemented site-specific fall protection and confined space programs during the execution of this contract.
